#### ARTICLES OF INCORPORATION

BE IT KNOWN, that the undersigned, at least three of whom are residents of the Commonwealth of Pennsylvania and citizens of the United States, and all of whom are of full age, having associated themselves together for the purpose of organizing the White Clay Watershed Association, and being desirous of becoming incomporated in accordance with the provisions and requirements of the act of the General Assembly of the Commonwealth of Pennsylvania known as the "Nonprofit Corporation Law" approved May 5, 1933, as amended, do hereby declare, set forth and certify as follows:

- 1. That the name of the corporation is the White Clay Watershed Association and that said name has been registered with the Department of State within six months of the date of the application for this charter.
- 2. That the location and post office address of its initial registered office in this Commonwealth is c/o Gwendolyn Cramer, South Bank Road, London Britain Township, R. D. #1, Landenberg, Pennsylvania 19350.
- 3. That the purpose or purposes of the corporation are: to promote the development and preservation of the natural resources of the White Clay Watershed so that all residents will have a better place in which to live, work, and play; to protect economic and esthetic values, to insure the quality and quantity of water, to conserve water, soil, woodland, open space, and wildlife; to develop outdoor recreational facilities, to beautify and improve the community, to educate the people of the Watershed in the aims and program of the Association, and to cooperate with all compatible programs whether individual, group, industrial, municipal, county, state, interstate, or federal. This is a corporation which does not contemplate pecuniary gain or profit, incident or otherwise, to its members.
  - 4. That the term of its existence is perpetual.

#### ARTICLES OF AMENDMENT

BE IT KNOWN, that in compliance with the requirements of Article VII of the Act of the General Assembly of the Commonwealth of Pennsylvania known as the "Non-profit Corporation Law" approved May 5, 1933, as amended, providing for amendments to the Articles of Incorporation of non-profit corporations, the WHITE CLAY WATERSHED ASSOCIATION hereby certifies under its corporate seal:

- 1. That its name is the White Clay Watershed Association and that its registered office is located c/o Gwendolyn Cramer, South Bank Road, London Britain Township, R.D. # 1, Landenberg, Pennsylvania 19350.
- 2. That it is a corporation incorporated and existing under the Act of the General Assembly of the Commonwealth of Pennsy-Ivania known as the "Nonprofit Corporation Law" approved May 5, 1933, as amended June 19, 1969; and that the Articles of Incorporation were approved by the Department of State of the Commonwealth of Pennsylvania on November 30,1970.
- 3. (a) That a meeting of the members of the White Clay Watershed Association to take action upon the proposed amendment was held on the 29th day of November , 1971 at Kemblesville, Pennsylvania

pursuant to written notice to the members at least ten (10) days prior to the date of the meeting.

- (b) That at the time of the meeting of the members on the day of November 29 1971, 70 members were entitled to vote on the proposed amendment and that 60 members voted in favor of the adoption of the resolution authorizing the application to the Department of State for the amendment to its Articles of Incorporation.
- 4. That the following resolution was adopted by at least a majority of the members entitled to vote thereon:

"RESOLVED, that the following be added as a new Paragraph 9 to the Articles of Incorporation: in the event of the dissolution of this Corporation, distribution of the assets of the Corporation

remaining at that time shall be made only to a similarly exempt organization as described in Section 501 (c) (3) of the Internal Revenue Code."
